Under the terms of this Agreement, users of AIRTRAQ CAM APP are not entitled to technical support. However, Prodol Meditec will make its best efforts to respond, at the earliest, to support requests related to AIRTRAQ CAM APP.

AIRTRAQ CAM APP is licensed to users in accordance with the terms and conditions of this Agreement.

The User represents and warrants that requirements of this Agreement will not be violated and further represents and warrants that will not permit others to:

- (i) reverse engineer, decompile, disassemble, derive the source code of, modify, or create derivative works from AIRTRAQ CAM APP, or
